1. **Bagmati Municipality, Office of the Municipal Executive has allocated funds from GoN /Bagmati Municipality** towards the cost of Construction of Shakhuwani Agriculture Market Infrastructure of Bagmati Municipality and intends to apply part of the funds to cover eligible payments under the Contract for **NCB/WORKS/BM/2082/083/04**. Bidding is open to all eligible as per Section V of bidding document.
2. **Bagmati Municipality, Office of the Municipal Executive** invites electronic bids from eligible bidders for the construction of Shakhuwani Agriculture Market Infrastructure of Bagmati Municipality under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 10,34,96,000.00
- Minimum Work experience of similar size and nature: **1 project of RCC frame structure building of value NRS. 8,27,97,000.**

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Bagmati Municipality, Office of the Municipal Executive, Karmaiya, Sarlahi** or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
5. Interested Bidder may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document Nrs. 10,000.00 in the account as specified below .

7. Electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) at **12:00 on 2026/02/17**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2026/02/17** at the office of **Bagmati Municipality, Office of the Municipal Executive, Karmaiya, Sarlahi**. Bids must be valid for a period of **120** from the bid submission deadline

and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS 36,57,000** which shall be valid for 30 days beyond the validity period of the bid.

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
