

Invitation for Bids

1. The Municipality has allocated funds towards the cost of Construction of blacktopped roads in Bagmati Municipality ward no. 12,11,4. and intends to apply part of the funds to cover eligible payments under the Contract for Construction of blacktopped roads in Bagmati Municipality ward no. 12,11,4. (Contract No: BM/WORKS/NCB/03/2079/080). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Bagmati Municipality, Office of Municipal Executive invites electronic bids from eligible bidders for the construction of Construction of blacktopped roads in Bagmati Municipality ward no. 12,11,4. under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 24 crore
Minimum Work experience of similar size and nature: One (1) Contract of blacktop road with asphalt concrete within the last ten (10) years, with a value of at least NRs 9.7 crore.

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bagmati Municipality, Office of Municipal Executive, Karmaiya, Sarlahi, Province Two, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Bagmati Municipality, Office of Municipal Executive, Karmaiya, Sarlahi, Province Two, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 10000.0 NRs. till 23-11-2022 11:00 during office hours.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

7. Sealed or electronic bids must be submitted to the office Bagmati Municipality, Office of Municipal Executive, Karmaiya, Sarlahi, Province Two, Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 23-11-2022 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 23-11-2022 13:00 hours at the office of Bagmati Municipality, Office of Municipal Executive Karmaiya Sarlahi Province Two Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 5495000 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
10. Evaluation and Qualification Criteria:

General Construction Experience:

Experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least the last 5 (Five) years prior to the applications submission deadline.

Note:

(1) Insert number of years in words and figures. The time period is normally 5 years, but may be reduced to not less than 3 years, according to the nature of works.

Contracts of Similar Size and Nature

(ii) For Works with value above NRs. 50 million:

Participation as Prime contractor, management contractor, or subcontractor, in at least One (1) Contract of blacktop road with asphalt concrete within the last ten (10) years, with a value of at least NRs 9.7 crore that have been successfully or are substantially completed and that are similar to the proposed works. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
