**Construction of Shiva Parbati Statue at Proposed Sumeru Parbat**

1. The Office of the Municipal Executive, Bagmati Municipality, Sarlahi *has allocated funds* towards the cost of **Construction of Shiva Parbati Statue at Proposed Sumeru Parbat** and intends to apply part of the funds to cover eligible payments under the Contract *for Construction of Shiva Parbati Statue at Proposed Sumeru Parbat* (NCB/EPC/WORKS/03/2080/81). Bidding is open to all eligible as per Section V of bidding document.
2. The Office of the Municipal Executive, Bagmati Municipality, Sarlahi invites electronic bids from eligible bidders for the construction of *Construction of 30-Meter-Tall Shiva and Parbati Statue with the RCC and Structural Steel Structure* through Engineering Procurement Construction (EPC) mode under **National Competitive Bidding – Single Stage Two Envelope Bidding procedures.**

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 184,700,000.00**
  - Minimum Work experience of similar size and nature: *At least one EPC/Turnkey/Design and Built Contract of Similar Nature; single project with minimum of NRs. 147,710,000.00 contract Value*
  - Concept paper for Understanding of the Project and Proposed Design
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit the Technical Bid and the Price Bid, as per the provision of ITB 21 of the Bidding Document.
  4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of The Office of the Municipal Executive, Bagmati Municipality, Sarlahi or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
  3. Bidder submitting their bid electronically shall download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding **document (non-refundable fee) of NRs. 20,000.00** in the Project's Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at The Office of the Municipal Executive, Bagmati

Municipality, Sarlahi at **30-05-2024 14:00**.

6. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00** on **14-06-2024**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14-06-2024 14:00** at the office of **Bagmati Municipal Executive**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum of **NRs. 9232000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
