1. Bagmati Municipality, Office of Municipal Executive invites electronic bids from eligible bidders for the **Construction of grain storage warehouse** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 9 crore
Minimum Work experience of similar size and nature: At least one building value of which is not less than 3.2 crore.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate ELECTRONIC BIDS one containing (i) the Technical Bid and the other (ii) the Price Bid as per the provision of ITB 21 of the Bidding Document.
Hard copy submission is not allowed.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of
Bagmati Municipality, Office of Municipal Executive, Karmaiya, Sarlahi, Province Two, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidder can submit their bid electronically by downloading the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document RS.5000 (non refundable) in the Project's Rajaswa (revenue) account as specified below:

Karmaiya, Sarlahi, Province two, through PPMO's e-GP system www.bolpatra.gov.np/egp

on or before 24-11-2020 12:00. Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 24-11-2020 13:00 hours at the office of Bagmati Municipality, Office of Municipal Executive Karmaiya Sarlahi Province Two Nepal.

8. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format , amounting to a minimum of NRs. 1500000 (fifteen lakhs) which shall be valid for 30 days beyond the validity period of the bid.

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
